Part III- Bridge of Wings provides direct financial assistance to pancreatic cancer patients for essential needs such as groceries, transportation, insurance, car payments, and other household expenses. The program helps alleviate financial burdens so patients and families can focus on treatment and care. In 2025, Bridge of Wings assisted patients with over \$129,000. The \$32,900 given in gas cards helped patients drive 101k miles to get to lifesaving treatments. Continued partnership with Dr. Andrew Page and Piedmont Healthcare in Atlanta to develop and facilitate the Nancy Lyle Ambassador Program, including training and supporting patient and caregiver ambassadors and facilitating all patient and caregiver sessions. Continued to offer our Thrive Together, twice-monthly virtual support program, connecting pancreatic cancer patients with one another and with resources to help navigate the challenges of living with the disease. Sessions provide a safe, supportive space to discuss topics including nutrition, mental health, symptom management, treatment challenges, and quality of life. The program helps patients feel connected, informed, and less alone throughout their cancer journey.
